**ACC NON-CONFERENCE
BASKETBALL CONTRACT**

This Agreement entered into this _____ day of _____, 200__, by and between North Carolina State University, c/o Athletics Department, Campus Box _____, _____ (Bldg. and Street) _____, Raleigh, NC 27695-_____, (HOME TEAM), and _____ (name and address) _____, (Contractor, VISITING TEAM).

1. The eligibility of all players to participate in said game shall be determined by the rules and regulations of the ATLANTIC COAST CONFERENCE and the _____ CONFERENCE; each team subscribing to the rules and regulations of its own conference or Institution, if non-affiliated.
2. The HOME TEAM agrees to pay the VISITING TEAM the sum of _____ Dollars (\$_____) as a guarantee for playing said game.
3. The HOME TEAM agrees to furnish the VISITING TEAM _____ complimentary tickets. (If possible, these seats are to be placed behind the visiting team bench.)
4. The VISITING TEAM Official party shall consist of a maximum of twenty-three (23) persons. The HOME TEAM will furnish eighteen (18) chairs for players, coaches, trainer, and doctor during game.
5. Officials shall be appointed by the ATLANTIC COAST CONFERENCE and the _____ CONFERENCE.
6. Radio broadcast of the game shall be under the control of the HOME TEAM. The rights of each team are as follows: The HOME TEAM shall retain the revenue from and full control of radio rights, but with the understanding that the VISITING TEAM shall have one outlet free of charge and the revenue derived therefrom.

7. Television: The basketball games contracted for in this agreement may be televised or cablecast only with the mutual consent of the parties hereto. If it is agreed that any of the games under this contract are to be televised or cablecast, the parties will enter into a separate agreement for the telecast or cablecast of each such game. Unless otherwise provided in such separate agreements, the HOME TEAM shall ordinarily have the right to negotiate the arrangements for a telecast or cablecast of a game, and a division of rights fees will be determined for each such game. All rules, regulations, and relevant contractual obligations of the conference to which the parties may belong which are applicable to televising or telecasting basketball games must be complied with, and all rules and regulations of the NCAA must also be complied with.

8. The HOME TEAM may terminate this agreement for cause at any time by 30 days notice in writing from HOME TEAM to VISITING TEAM.

9. ACCESS TO PERSONS AND RECORDS: The State or University auditor shall have access to persons and records as a result of all contracts or grants entered into by State agencies or political subdivisions in accordance with General Statute 147-64.7.
